1. The name of the TRUST shall be **MAHENDRA MEMORIAL TRUST** with its registered office at Vill + Post : Sindrani, Dist:North 24 Parganas (W.B), Pin:743297. The Trustees or the Managing Trustees shall have power to open additional offices of the TRUST. The registered office can be shifted to any other location with the unanimous decision of the permanent trustees.
3. That the Trust shall be entitled to operate all over India.
4. The TRUST has been established only for charitable purposes including imparting and advancement of any other object of general public utility including relief to poor and down-trodden, not involving carrying on of any activity for profit and also more specifically mentioned as follows :-
- To acquire, establish, start, aid, run, maintain or manage, school, colleges libraries for the benefits of the public.
 - To affiliate and / or associate with different councils for technical education.
 - To arrange and organize lectures, debates, discussions, seminars & excursions for diffusion of knowledge.
 - To help the students of all communities, for persecution of studies.
 - To construct, maintain, improve, develop and alter any buildings, houses hostel and crèche or other works necessary or convenient for the Trust.
 - To open, found, establish, promote, set-up, run, maintain, assist, finance, support and / or aid or help in setting up and / or maintaining and / or running schools, colleges, lecture halls and other establishments or institutions for computer education, business management, medial and paramedical, engineering, hotel management, fashion technology, multimedia and other subjects in commerce, science and arts field and all other useful subjects in all manifestations and spread of other knowledge useful for mankind.
 - To assist, help and encourage keeping of the environment clean and tidy and for that purpose, to take appropriate steps for pollution-free atmosphere at land, air and water.
 - To accept any gift or donation of movable or immovable property from any person or persons or any other charitable organization or to accept merger of such charitable organization(s) with the Trust solely for the purpose of encouraging the objectives and activities of the Trust.
 - To promote employment generation for private as well as government sector.
 - To promote education in the field of computer, management and also some vocational courses for low income group of people at an affordable cost.
 - To provide financial assistance to the poor and needy for their medical treatment, shelter, feeding, clothing, education etc. in deserving cases.

k) The TRUSTEES shall stand possess of the each of the said money hereby conveyed and settled as well as all interests received out of investments of the same as also of any other cash, monies movable and immovable properties, gift, donations etc. received from generous people or institutions, hereafter and for the subject matter of the Trust referred to as "The Trust Fund".

l) The cash hereby conveyed to the Trustees shall form the corpus of the TRUST property, but the Trustees shall have power from time to time to increase or decrease the corpus, subject to never the less to the following provision which the Trustees shall have no power (except as hereinafter mentioned) to alter modify or abolish, that is to say :-

i) That the securities and or investments shall not be transferred, relinquished, sold out, exchanged or otherwise dealt with in a manner which shall invite the levy of income tax on the income of TRUST property.

ii) That the cash hereby conveyed as well as the corpus fund of the TRUST shall be utilized only for the purpose of making investments in a manner required by the Income Tax Act as in force in India at the material times, so as not forfeit the exemption of the income as per provision of Income Tax Act.

iii) That the conversion of any of the investment of the TRUST into any other investment shall be made in a manner determined with reference to the provisions of the Income -tax Act as in force in India so as to ensure to be fully exempt income tax, and

iv) That the corpus of the TRUST property shall not be decreased except in exceptional circumstances of need only on the unanimous decision of the Board of Trustees in that regard at the material time.

v) That the TRUST is entitled to join, co-operate or amalgamate with any other TRUST having similar objectives as also accept merger of other TRUST / TRUSTS with itself similar objectives with the unanimous approval of the permanent Trustees.

vi) That the TRUST is irrevocable.

vii) That the TRUST can only be dissolved by order of the competent court or any other court having jurisdiction in the matter.

viii) Without affecting the generality of powers and function of the TRUSTEES to manage and administer the TRUST, the Board of Trustees shall have the following powers and function :-

i) To borrow, if need be against the security of the assets of the TRUST by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefit of the TRUST and for more effectively carrying out the objects of the TRUST. Provided however the permanent TRUSTEES unanimously agree for such borrowing and limited to the terms of their decision or agreement and to authorize anyone or more of the TRUSTEES to execute such documents, deed, papers etc. may be necessary in connection therewith.

- ii) To arrange for and / or authorize the signing or execution of any arrangement, contract, instrument document or any other paper or writing required to be signed or executed on behalf of the TRUSTEES by any one or more of the TRUSTEES to be nominated in this behalf by the BOARD of TRUSTEES and to make the same effective and binding as if the said agreement, contract, instrument on document or paper or writing were signed by all the TRUSTEES
- iii) To appoint or make provision for the appointment of a subcommittee of TRUSTEES and / or others to attend to or supervise or conduct specified jobs or functions or TRUST matter in such manner and subject to such rules and regulations as the TRUSTEES may prescribe
- iv) To authorize anyone or more TRUSTEES to hold any property or any fund or any investment on behalf of the Trust subject however to the terms of these presents in such manner subject to such terms and conditions, rules regulation as the Board of Trustees may time to time think fit and proper.
- v) To spend any portion of the corpus or the income the TRUST, fund for purchasing any land or constructing any building or buildings for the purpose of carrying out promoting and / or executing any or all the objects of the TRUST.
- 11) The TRUSTEES may invest the Trust Estate either in the purchase of immovable properties or in such manner allowed by law as may be in force time to time to convert, alter vary, dispose of or transfer such investments from time to time provided that such investments shall not be made which are directly or indirectly for the benefit of any person referred to in sub-sec.(3) of sec. 13 of Income Tax Act, 1961, or any subsequent amendments as may from time to time.
- 12) If the income from the TRUST property in a particular year is not fully utilized, the unexpended income subject to the applicable provisions of the Income Tax Act, 1961 shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the objects of the TRUST.
- 13) The TRUST shall be at liberty to sell such portion or portions of the movable or immovable properties forming part of the Trust Estate either by public auction or by private contract at such price or prices and in such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and rescind or vary any contract for the sale thereof and to resell the same without being answerable for any loss occasioned thereby and to execute all conveyances or other assurances and to pass valid and effectual receipts and discharges or other moneys received by them.
- 14) The TRUSTEES shall keep an account or accounts with any schedule bank or banks to operate such account or accounts whether in debit or in credit and to give all appropriate instructions to the banker or bankers concerning the operation of such account or accounts and to authorize by appropriate resolution to operate such account or accounts by the Managing Trustees singly or by any other two Trustees jointly and / or by any other authorized person.
- 15) The Trustees or Managing Trustees may pay all charges and outgoing payable in respect of any immovable property for the time being forming part of the Trust Fund and may carry out repairs required to be done to the same and keep the same

insured against loss or damage by fire and may incur all other costs charges and expenses incidental to the administration and management of the Trust Estate and the properties for the time being belong to the TRUST as Trustee Board in their absolute discretion think(s) fit.

- 16) The Trustees or the Managing Trustees may manage or supervise the management of any lands, hereditaments and premises for the time being comprised in the Trust Estate or any part thereof.
- 17) The TRUSTEES or the Managing Trustees may appoint Secretaries, Managers, Lawyers, Solicitors, Auditors, Architects, Engineers, Surveyors, Gomastas or other employees for the purpose of management and supervision of the Trust Estate for collection of rents, effects and profit, for keeping the accounts and records and for other purpose of the TRUST, and to pay to him / they out of the TRUST FUND such remuneration/ fee as the Trustees or the Managing Trustees think(s) fit. Where, however if anyone of the Trustees be appointed as the secretary / manager, he shall not be entitled to receive nor shall be paid any salary. The Trustees or the Managing Trustees may also appoint such staff as they / he deem(s) expedient and necessary for the purposes of the TRUST at such salary as they /he may decide upon in each case.
- 18) The TRUSTEES or the Managing Trustees may establish its office at such place or places and may change such places from time to time as they / h may think fit.
- 19) The Trustees or the Managing Trustees may demise the immovable property or properties for the time being and from time to time belonging to the TRUST either from year to year or for any fixed term or for any term of year or on monthly tenancies at such rent and subject to such covenants and conditions as they / he may think proper and also accept surrenders of lease and tenancies and generally manage the same in such manner as they / he think(s) fit and proper.
- 20) The TRUSTEES or the Managing Trustees shall have power to compromise or compound all actions and other proceedings and settle differences and disputes touching the Trust Estate and / or the Trust Properties and to refer any such differences or disputes to arbitration and / or to adjust and settle all accounts relating to the Trust Estate and/or the Trust Properties and to do other acts and things fully and effectively without being liable or answerable for any bonafide occasioned thereby.
- 21) The board of Trustees or to Managing Trustees shall have power to accept donation from other in cash / cheque either with or without any special conditions attached thereto PROVIDED that any such condition does not contravene the provisions of clause 4 thereof. Subject to the same restriction, the Board of Trustees or the Managing Trustees may at any time invites and receive from person whosoever periodical contribution or subscription for the support and benefit of TRUST hereby constituted and declared.
- 22) The TRUSTEES may from time frame schemes and rules and regulation to carry out the objects of the TRUST and for managing the affairs of the TRUST and otherwise for giving effect to the objects and purpose of TRUST and to vary the same from time to time as the TRUSTEES may in their discretion deem fit and proper.
- 23) The receipts grants by any two TRUSTEES or by the Managing Trustee for any moneys, stocks, funds, shares, securities or investments paid, delivered or

transferred to them / him in exercise of the TRUST or powers hereof shall effectually release and discharge the person paying, delivering or transferring the same there from and from seeing or from being bound to see the application thereof or being answerable for the loss or misapplication thereof.

- 24) The TRUSTEES shall be entitled at their discretion from time to time to start, discontinue, abolish and restart any charity or charitable institute to impose any condition or conditions to any subscription or donation made by them and to landmark any portion of the Trust Property or income for any particular objects or objects.
- 25) The TRUSTEES may reimburse themselves and pay and discharges out of the Trust fund all expenses incurred by them in or about the execution of the TRUST or any of their duties these presents including traveling expenses but will not be entitled to any remuneration.
- 26) The administration of TRUST hereby constituted and the entire control supervision regulation management of the TRUST property and even the application of the entire or a part of the income and the profits thereof as also of all the documents and contributions and subscription, if any received by it shall vest in the uncontrolled discretion of the Board of Trustees subject however always to the provisions contained in these presents.
- 27) The TRUST shall be governed by the board of Trustees. The Board of Trustees appointed by this Trust Deed shall be permanent trustees who shall hold office for life unless one or more of them resigns in writing.
- 28) The permanent Trustees shall have power to appoint unanimously not more than two person as the Trustees(s) of the TRUST, such new appointed Trustee(s) shall hold office for such period as the permanent Trustees may unanimously decide.
- 29) The board of Trustees may frame rules and regulation for the administration of the TRUST and for carrying out the purpose and object thereof and same may be varied altered, substitute or added to from time to time by a majority decision of the Board of Trustees with a view to introduce more effective administration and carrying out the purpose and the object of the TRUST. Such rules may specifically provide the basis or criterion for selection of the poor for providing relief. The rules may also provides the basis or criterion of selection of students for the award of scholarships, grants and / or other benefits in a most befitting manner and may even make provision for the selection of the students for grant of scholarships, grant and / or benefits by the Education Department of the government or by any university, college or other educational body or institution, whether in government or in private in engineering, medical, paramedical, management, commerce, sciences or arts fields etc. Without limiting the field of knowledge in general. Where special relief is provided the Board of Trustees may make specifically the basis and criterion on which such relief is to be provided. Similarly rules may be specifically framed by the Board of Trustees for advancement of other object/s of public utility. It is however, understood that such rules shall in no case provide for selection on the basis of caste, creed or religion to which the people belong, although preference may be given to people belonging to the scheduled caste or scheduled tribes.
- 30) The number of TRUSTEES shall be not less than two and not more than Nine.

- 31) Any TRUSTEES may retire at time by giving notice in writing to the Board of Trustees at the principal place of office of the trust without assigning any reason for such retirement.
- 32) The surviving or continuing TRUSTEES may, not withstanding any vacancy in the Board of Trustees, act as TRUSTEES. Provided however that if the number of TRUSTEES falls below the minimum number of Trustees of two because of the vacancy caused by retirement, resignation, death or otherwise for whatsoever reason, the sole surviving trustees cannot act on behalf of the Board of Trustees singly except for the purpose of appointing one or two new Trustees to from part of the Board of Trustees.
- 33) One third Trustees at a meeting shall form a quorum for any meeting of the TRUSTEES.
- 34) Tarak Chandra Roy Shall be chairman of the Board of Trustees and he shall continue to hold office as chairman unless he resigns or refuse to act as chairman or otherwise ceases to be TRUSTEE. In the event of Tarak Chandra Roy ceases to be a trustee, Raj kumar jain or Tanmay Roy shall be the chairman of the Board of Trustees. Raj Kumar Jain or Tanmay Roy shall preside the meeting of the TRUST in which the chairman is absent.
- 35) Tarak Chandra Roy shall be the Managing Trustees of the TRUST and shall be entitled to take all important decisions on behalf of the TRUST for effective discharge of his duties and function as the Managing Trustees of the TRUST, subject to the overall supervision and guidance of the Board of Trustees of the TRUST and further to such limitations and/ or restrictions as are contained in this.
- 36) The Managing Trustee shall be the Managing Trustee for life unless he resigns as the Managing Trustees earlier by giving notice in writing to the Chairman of the Board of Trustees and his resignation has been accepted unanimously at a meeting of the Board of Trustees specifically convened for the purpose of considering such resignation. The resignation of the Managing Trustee as the Managing Trustees, even if accepted in the manner as aforesaid, shall not act as his resignation from the trusteeship of the Board of Trustees and he shall continue to be a trustee of the TRUST for life. The Managing Trustee may withdraw his resignation at any time before it is accepted in the manner as aforesaid.
- 37) The Managing Trustee shall have all the powers to act for and on behalf of the TRUST and the Board of Trustees subject to the Provisions, restriction and limitation contained in the Trust Deed and shall not be accountable to any body for all acts done in good faith by him on behalf of the TRUST.
- 38) Subject to other provision of this Trust Deed, all proceeding and question and matter arising at the meeting of the TRUSTEES shall be decided by a majority of votes and in case of equality of votes the Chairman shall have a second or casting vote.
- 39) In case of difference of opinion between the TRUSTEES the opinion of the majority shall prevail and if the TRUSTEES are equally divided in any matter, the Chairman shall have a casting vote.
- 40) Subject to the other provisions of this Trust Deed, a resolution in writing circulate amongst all the TRUSTEES and signed by a majority of the TRUSTEES shall be

as valid and effectual as if it had passed at a meeting of the TRUSTEES duly called and convened.

- 41) Notice of the meeting of the TRUSTEES and communications may be sent to the TRUSTEES at their address registered for the time being in the records of the TRUST.
- 42) All meetings of the TRUST shall be held at such place and at such time as the chairman of the TRUST shall decide from time to time.
- 43) A TRUSTEE who is unable to be present at a meeting of the TRUSTEES may send his views on the agenda in the writing and such expression of opinion, if the same can be construed as a vote, shall be taken to be his vote on the matter concerned.
- 44) The minutes of the proceedings of every meeting of the TRUSTEES shall be entered in the book to be kept for the purpose and signed by the Chairman of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matter transacted at such meeting.
- 45) No person being:-
 - i) an undischarged insolvent; or
 - ii) convicted of an offence involving moral turpitude; or
 - iii) of unsound mind; or
 - iv) a minor shall be eligible to be TRUSTEE.
- 46) Subject to other provisions of this Trust Deed, the power to appoint new or additional TRUSTEES, so as no to exceed the maximum number and to fill the vacancies in the office of the TRUSTEES, shall vest in the continuing TRUSTEE or TRUSTEES.
- 47) A person shall cease to be a TRUSTEE in any of the following events:-
 - a) if he dies; or
 - b) if he becomes bankrupt; or
 - c) if he becomes insane or otherwise become incapable to act;
 - d) if he resigns his office.
- 48) On a new or additional TRUSTEES being appointed and on signifying his acceptance in writing to the effect of his accepting the appointment, the Trust Property shall automatically vest in him alongwith other TRUSTEES for the time being and he will be entitled to carry out all the duties and functions of a TRUSTEE without any other deed or writing.
- 49) The Board of Trustees shall be entitled to sue in the name of TRUST and may similarly be sued in the name of TRUST.
